




## BENEFITS REALISATION REPORT



Primary Sense is a Primary Health Network owned and operated population health management, clinical decision support and data extraction tool. It extracts de-identified general practice data and uses evidence-based algorithms to provide GPs with real time medication alerts, reports and patient care prompts.

Primary Sense was developed in 2017 by the Gold Coast PHN and has since been adopted nationally, currently in use by 12 PHNs. WA Primary Health Alliance now manages Primary Sense on behalf of PHNs and has responsibility for development and management of Primary Sense.

## **KEY FINDINGS**

In 2023/24, Gold Coast PHN's demonstrated progress against a broad range of Primary Sense benefits, with targets for most KPIs met.
